RESOLUTION NO. 18-19-39

AUTHORIZATION TO APPLY FOR FUNDING UNDER THE FULL-DAY KINDERGARTEN FACILITIES GRANT PROGRAM (FDKFGP)

WHEREAS, the Full-Day Kindergarten Facilities Grant Program, Education Code 17375, became effective June 27, 2018; and,

WHEREAS, the sum of one hundred million dollars (\$100,000,000) is appropriated from the General Fund to the State Allocation Board to provide one-time grants to school districts to construct new school facilities or retrofit existing school facilities for the purpose of providing full-day kindergarten classrooms pursuant to Section 8973; and,

WHEREAS, the State Allocation Board shall award grants to school districts that lack the facilities to provide full-day kindergarten as required for eligibility pursuant to Section 17071.25 and 17072.10 or that lack facilities that satisfy the design requirements required for new kindergarten classrooms as specified in paragraph (2) of subdivision (h) of Section 14030 of Title 5 of the California Code of Regulations; and,

WHEREAS, priority for grants shall be given to school districts that meet the requirements for financial hardship pursuant to Section 17075.10; and are located in an underserved community with a high population of pupils who are eligible for free or reduced-price meals pursuant to Section 42238.01; and,

WHEREAS, the San Jacinto Unified School District understands that there is no guarantee of funding based on the priority points of applications received by the Office of Public School Construction; and,

WHEREAS, the San Jacinto Unified School District has to provide its 50 percent local matching share for new construction projects; and its 40 percent local matching share for retrofit projects unless the school district meets the requirements for financial hardship pursuant to Section 17075.10;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of the San Jacinto Unified School District authorize District staff to apply for funding under the Full-Day Facilities Grant Program in order to retrofit and/or purchase classrooms at San Jacinto Elementary and Hyatt Elementary; and,

As a condition of receiving grants funds pursuant to this section and before the release of those funds, the school district shall execute and submit a grant agreement consistent with the application section of the grant agreement specified in Section 1859.90.4 of Title 2 of the California Code of Regulations.
