**RESOLUTION NO. 19-20-02,
PUPIL TEXTBOOK AND
INSTRUCTIONAL MATERIALS COMPLIANCE
PURSUANT TO EDUCATION CODE SECTION 60119, 60422, 60210,
60605 AND 60605.8
FOR FISCAL YEAR 2019-2020**

WHEREAS, the Board of Trustees of the San Jacinto School District, in order to comply with the requirements of Education Code Sections 60119, held a Public Hearing on September 10, 2019, at 6:00 p.m., which is on or before the eighth week of school (between the first day that students attend school and the eighth week from that day) and the hearing did not take place during or immediately following school hours; and

WHEREAS, the Board of Trustees provided at least 10 days notice of the Public Hearing posted in at least three public places within the District that stated the time, place, and purpose of the hearing; and

WHEREAS, the Board of Trustees encouraged participation by parents, teachers, members of the community and bargaining unit leaders in the Public Hearing; and

WHEREAS, information provided at the Public Hearing detailed the extent to which textbooks and instructional materials were provided to all students, including English Learners, in the San Jacinto Unified School District; and

WHEREAS, the definition of "sufficient textbooks or instructional materials" means that each student, including each English Learner, has a standards-aligned textbook or instructional materials to use in class and to take home, which may include materials in a digital format but shall not include photocopied sheets from only a portion of a textbook or instructional materials copied to address a shortage, and;

WHEREAS, textbooks and instructional materials were provided to each student in core curriculum subjects should be aligned with state academic content standards adopted by the State Board of Education pursuant to Education Code 60505 and/or the Common Core State Standards adopted pursuant to Education Code 60605.8; and

WHEREAS, sufficient standards-aligned textbooks or instructional materials that are consistent with the cycles and content of the curriculum frameworks were provided to each student, including each English Learner, in the following subjects: Mathematics, Science, History/Social Science, and English/Language Arts, including the English Language Development component of an adopted program, World/Foreign Language, or Health.

WHEREAS, sufficient laboratory science equipment was available for science laboratory classes offered in grade 9-12, inclusive.

NOW, THEREFORE, BE IT RESOLVED, that for the 2019-2020 school year, the San Jacinto Unified School District has provided each pupil with sufficient textbooks and instructional materials consistent with the cycles and content of the curriculum frameworks.
