I would like to make the following comment:

Good afternoon President Norman, Board members, Superintendent Pyle and Cabinet members,

Today I bring my concerns, not only as the PTA President of Edward Hyatt World Language Academy, but more importantly as a parent of 2 children who are currently in the DI program. When I enrolled my child in the DI program, as a parent I was thrilled to give my child this great opportunity of becoming bilingual and biliterate. However, as the years have gone by I have many concerns and my discontent and disillusionment has grown. From the very beginning, I have been a very active parent and have been involved in all the possible committees at our school, in order to support my children's education. In the beginning years, this was quite rewarding, but

after living through so many constant changes to staff, administrators and DI directors, and especially lately, it has become very frustrating. All this constant turnover has created so much havoc and disruption, and honestly it has not been in the best interests of the students, families and staff! We, the families, are not treated with transparency or respect.

For starters, I do not understand how our DI program can be successful with such a small school budget. Being on the School Site Council Committee, at our last meeting we were told how from an initial budget of about \$65000 we ended up with roughly \$6000, after paying our half of the reading intervention teacher's salary. Can Hyatt, a school of about 500 students run a school on only \$6000 for the year? Which brings me to the intervention teacher. Why is she only offering intervention to students in kindergarten through the 3rd grade. We as the committee, on behalf of all of our families, would like intervention and tutoring services to be offered to students from kinder to 6th grade. Plus, we feel it is essential that the lowest performing kids receive this intervention, as they are the ones who most desperately need it, not the bubble kids who are already on the verge of reaching proficiency. As a SSC committee we requested several times to get a copy of the school budget. It took months to see the 2019-2020 plan. Working on the 2020-2021 school year SPSA plan, we were very clear and asked Mrs. Luna to give it to us one week prior so that we could look it over before the meeting. This did not happen, and when she presented the SPSA it was via a Zoom meeting. We could see it had 60+ pages but she quickly scrolled through maybe half of them. The terminology used was vague at best and there were no dollar amounts clearly delineated for her suggested expenditures. 3 of us SSC committee members, all at separate times in the meeting, brought up that maybe it should first be finished and sent out to us to look over, before we voted on it. Unfortunately, we were all shut down and told that either it was approved that very day or we would have to revisit it in late August/early September. We felt very uncomfortable and no one on the committee motioned to approve it.

Why their is such a big lack of transparency?

Why we don't receive the information and documents that we request? It is this secretiveness that causes more questions and lack of trust, that is so detrimental for our kids.

Moving on to my next big concern- my son has a 504 Plan. I know for a fact that the teacher was aware since she herself went over the plan with me at the beginning of the school year. So why, now at the end of the year, do I find out that he has not received any of the accommodations laid out in his 504 Plan. As a matter of fact he is currently in summer school, with the same teacher, and I received an email yesterday that stated that his accommodations will be limited. Why? Isn't this a legal document where the 504 Plan needs to be upheld and respected?

I would like to make the following comment:

Good Afternoon to all, esteemed Board Members, President John Norman, Superintendent Pyle and Cabinet members:

I have been in constant communication with Cabinet members but I write this comment to you, the School Board, in order to bring to light a couple of things. First, we the parents of Edward Hyatt World Language Academy, would like more clarity and transparency with regards to our DI program. It has been 6 years now, and we are now being told that SJUSD still does not have a DI plan in place, but are currently working on it. What is taking so long, if this has been in the works since Year 1? Next, the Seal of Biliteracy Pathway-- this also should have been established and in place by now. Our 5th graders should have been recognized and acknowledged. I know that now, after the fact, you are trying to make things better by informing parents that you will recognize the students in the Fall, but if this had really been the case, I would think you would have mentioned it during their virtual promotion. Instead you left the poor kids waiting around for a big surprise and yet no mention of this milestone achievement was ever made, nor did the big surprise ever materialize. You do realize that many of us parents in DI kept up our commitment to stay in the program through the 5th grade, but many are now leaving to go attend the Leadership Academy and the Western Science Center because we do not feel confident that you have a firm Middle School plan in place for our future 6th graders. We have had two Middle School meetings with Mrs. Luna and the plans presented are very vague and disorganized, as if the decisions are being made on the fly based on the parents' immediate questions and comments.

Next thing, we are not sure if you realize it or not, but you have some amazing teachers in the DI program who work whole-heartedly to keep us parents here and committed, yet year after year you keep on clipping their wings. And then to make matters worse, at all the parent meetings, their admin leaders keep bashing their hard work and blaming them for the students' low test scores. In reality aren't the DI students outperforming their counterparts in SJUSD, and aren't they doing this while receiving the bulk of their instruction in Spanish, while becoming bilingual and biliterate? Instead of criticizing the teachers to the parents, shouldn't these teachers and the DI kids receive kudos, for keeping the DI program afloat, despite the constant changes in administrators and DI coordinators they have had year after year!

Lastly, as I informed some Cabinet members in a letter I recently sent them, I have been researching and analyzing education codes and have been in constant communication with our state's Department of Education. My conclusion and my takeaway is that parent committees are set in place for a specifically vital reason; which is to gather feedback from parents. Yes, parents are to give their honest unbiased opinion on the matters presented to them on how to best serve their

children and their specific needs and interests. In no way should parents ever have to feel marginalized, intimidated, reprimanded, disrespected, silenced and/or labeled as being overly-critical parents or troublemakers. My takeaway on all this information is that we, as parents, are supposed to be welcomed and encouraged to actively participate in these vitally important conversations and be allowed to give our opinions and be able to voice any and all of our concerns freely. Parents should not need to ask over and over for information or documents (sometimes having to wait weeks or even months). Nor should they have to wait eons for clarification, to best formulate their decisions when serving on a committee, such as the School Site Council or the ELAC committee. For example, with regards to school site budgets and SPSA plans, all information should be presented with transparency and clarity, and should be presented in a way that all parents can understand. This information should be easily accessible and quickly provided to them as a common courtesy, especially since it is public information. I do not like having to repeatedly ask for and push people to give me school plans, school site council agendas or minutes from previous meetings, when these should be automatically provided and/or easily accessible, something established by the Brown Act. I respect the authority given and placed on a school system, and it becomes very uncomfortable to be in the position of constantly having to ask, for such documents. We are all here to collaborate and work in an open, two- way, effective communication system. Our ultimate goal is to support our students, advocate for their success and empower our families to advocate for equity and access for all students. We should all be on the same page and on a collective mission to make the planning and elaboration of whatever plan will bring higher academic achievement and overall more success for the students, instead of it becoming a constant, annoying headache.

Sometimes in order for there to be real growth, we need to be able to address the elephants in the room and have difficult conversations, in order to be able to see the whole picture. We need to take a proactive and growth-minded approach and act, change or mend the gaps and broken pieces. It is not pleasurable for me to bring these concerns to the table, however I find it vitally important and necessary to address these, in order for further growth to be feasible for our DI program. Once we address these, we can build upon a fresh foundation and move forward with an open mind, that is willing to accept new ideas, make the necessary improvements and strive for growth and success, for the benefit and overall good of our students.
