2020-2021 Contracts/Agreements – Business Services

1. Caston, Inc. - Originally approved by the Board of Trustees on June 11, 2019. Change order CCO #62.07.05 for C1002297 is for additional drywall, soffits, and metal studs for New Middle School #4. Increase not to exceed \$2,441; funded by District Contract Allowance.
2. Computer Protection Technology - Computer Protection Technology will provide preventative maintenance for critical power protection equipment. Cost not to exceed \$47,860; funded by General Fund.
3. Conserve LandCare - Originally approved by the Board of Trustees on June 11, 2019. Change order CCO #61.02.01 for C1002287 is for temporary irrigation water connections for New Middle School #4. Increase not to exceed \$1,432; funded by District Contract Allowance.
4. Cornerstone Construction Service, Inc. - Originally approved by the Board of Trustees on April 7, 2020. Change order CO-03 includes a credit for rerouting the path of travel per DSA and locating a new fire hydrant. Change order includes an increase for additional pavement work, polyethylene encasement of pipes, adding a 6" concrete curb and adding an expansion joint in the concrete pavement for the Hyatt World Language Academy modular classroom project. Net decrease of \$27,412.
5. Innive, Inc. - Innive, Inc. will provide technology needs assessments and usage analysis services to the District through June 30, 2022. Cost not to exceed \$58,200 annually; funded by General Fund.
6. JPI Development Group, Inc. - Originally approved by the Board of Trustees on June 11, 2019. Change order CCO #63.18.07 is for gas pipeline trenching and relocating the sinks in Building D for New Middle School #4. Increase not to exceed \$17,231; funded by General Fund, Capital Facilities Fund and Measure Y.

7. PCH Architects - PCH Architects will provide architectural services for the Enrollment Center modular building and permanent building rehabilitation project. Cost not to exceed \$87,245; funded by General Fund.
8. R.I.S. Electrical Contractors, Inc. - Originally approved by the Board of Trustees on June 11, 2020. Change order CCO #64.19.10 is for revisions to the light fixtures for New Middle School #4. Increase not to exceed \$1,779; funded by District Contract Allowance.
9. Verizon Wireless - Originally approved by the Board of Trustees on July 23, 2020. Increase is for 200 SIM Cards and monthly service fees. Increase not to exceed \$21,550; funded by General Fund.
10. Zendesk, Inc. - Zendesk, Inc. will provide district-wide educational technology support through June 30, 2022. Cost not to exceed \$48,544 annually; funded by General Fund.

6. Riverside County Office of Education (RCOE) - Agreement between RCOE and SJUSD to provide extra duty for Career Technical Education (CTE) Instructor Jorge Ramirez for CTE meetings and events outside of contract day. Cost not to exceed \$2,016; funded by General Fund.
