Purpose and Description

The purpose of Comprehensive Support and Improvement plan is to address the barriers faced by our students meeting the criteria to be college and career ready as well as increasing the grad rate. Our grad rate has increased into the 90% range. Previously MHA had a grad rate in the 60% range. MHA should no longer be designated CSI. A-G courses are offered to all students as the standard schedule. Convincing students to retake non-A-G qualifying courses for a better grade has been a challenge.

MHA aligns practices under the Multi-Tiered System of Support (MTSS) framework to service the whole child as noted in the district Local Control Accountability Plan (LCAP). Integrating social and emotional learning, behavior support, and academic support in a comprehensive model will help to address the gaps in learning faced by our most vulnerable populations. Continuing to collaborate through a Professional Learning Community model refines our practices targeting struggling students.

Improving the graduation rate takes early intervention and constant communication with students and families. In the independent study environment keeping students connected to school and fostering positive relationships is essential to increasing the grad rate.

Essential Standards in the curriculum frameworks allow teachers to focus on high stakes tasks so that lesson design can be revised to meet the social and behavioral demands of the school climate "...fostering a student-centered culture ensuring equity and access through student voice." The philosophy of Mountain Heights Academy is reflected in the school's core values. The core values are examined at the beginning of each school year to assure their timeliness.

2020-2021 Plan Summary

The Story

Describe the students and community and how the school serves them.

Mountain Heights Academy serves students in grades 1st-12th. Most students range from 9th,10th,11th, 12th and some 5th year seniors. Our students come to us from other schools in and out of the district. The school operates an independent study program where students work at home and meet with a teacher once a week. Our goal is to provide flexible student centered learning and encourage students to keep making progress toward obtaining a high school diploma. We provide individual learning plans for all of our students. This all begins with the induction process. Students and families are referred to our school and then meet with our registrar. After the family completes the registration process the student and family then meet with the counselor for orientation which includes transcript evaluation and credits needed to graduate on time. Student then attends the first day of school with the master teacher who inducts them into the expectations and supports we have. During this day of induction our security officer then gives the student a tour of the school and explains the expectations again. Upon successful completion of induction our students begin. We use Exact Path and iReady universal screeners to determine student present academic levels. Each teacher meets with the students and assigns a course completion pathway with short term and long term goals. Every Week the teacher meets with the student for a progress report which is taken home.

SPSA Highlights

Key features of the SPSA include a focus on the student's individual needs. All students will be assessed in ELA and Math and based on those assessments a learning plan will be developed to fill gaps in learning using Exact Path and teacher created materials. ELL's will be placed in online classes for direct ELD services and indirect supports in core classes. MHA ELA/Math/Science/HSS teachers will continue to work with each student on writing to improve SBAC responses as seen on the SBAC responses (constructed response focus area--developing targeted rubrics/utilize mastery of item type to ensure students understand success criteria). Re-visit Thinking Maps and how these connect to formatting writing to prepare for SBAC--constructed response/performance tasks. Early intervention and supports for students not completing a minimum of two credits a week. Increase CCI with A-G grads, improved SBAC performance, college courses on and off campus, food handler certification, career education courses. Decreasing the Digital Divide by providing devices and internet connectivity for students in need.

MHA had greatest progress in grad rate. In 2019 our grad rate hit the 90th percentile with an increase of 28.8% points. ELA SBAC went up by +20.1 points and math went up by +4 points. Suspension rate maintained at zero suspensions.

Summary

Our greatest need is still in the area of College and Career Readiness. We plan to offer A-G courses and instructional supports. Baseline for 2019 is at 3.1% prepared. We plan to increase each year by 3%. Math SBAC scores are still in the orange range at -168 points below standard. Significant student groups Hispanic: -186.4 points below standard, declined -8.2 points, SED: 173.5 points below standard, increased by +3.6 points

SSC, ELAC, staff and students were included in the design and approval of the SPSA. Multiple meetings were used to get input and information.

Reflection on the mission, vision, and philosophy by students and staff is accessible through our ASB class and full staff meetings, but fielding fully formed ELAC (English Language Advisory Council) and SSC (School Site Council) committees can be a challenge.

The Board members for SJUSD are elected by the public, the district is broken into 5 territories and at max 2 seats are up for reelection at any time. San Jacinto High and Mountain View High school also each elect one student to be a student board member. These students then attend a training session at the beginning of the year to introduce them to the rules and restrictions of these offices. All the specific duties of the board are spelled out by State law.

We publish multiple surveys for all stakeholders to provide information and insight relevant to the nature of student learning. Site leadership coalitions also exist to provide ongoing support in curriculum, discipline, and social emotional learning.

Addendum

The SPSA Template

This SPSA template was adapted from the CDE [SPSA Template](#), and the SBE-approved [LCAP Template](#), and designed to meet the content requirements of *California Education Code* for a School Plan for Student Achievement. Such a plan must be developed and approved by the SSC at each school that participates in any program funded through the ConApp, and any programs the SSC decides to include.³ Accordingly, the plan must:

1. Be reviewed and updated annually by the SSC, including proposed expenditures of funds allocated to the school.
2. Align with school goals for improving student achievement that are based on verifiable state and local data.

7. Be developed with the review, certification, and advice of applicable school advisory committees.
8. Be reviewed and approved by the local governing board whenever there are material changes affecting the progress of students covered by these programs.

Seven Recommended Steps for Developing the SPSA

In addition to meeting the requirements common to all school plans, the SPSA must meet the specific requirements of each categorical program operated at the school. (Appendix A: Chart of Requirements for the SPSA lists the content for school plans required by state and federal programs operated at the school.)

The SPSA involves a continuous development, implementation, and monitoring cycle. The starting date of the annual planning cycle is a local decision. However, every school needs to have an approved plan guiding the work of the school. The SSC should develop a calendar of tasks and meetings to seek input from applicable advisory committees to develop the plan. The seven steps of this continuous cycle are:

1. Analyze student achievement data, summarize conclusions, and identify needs.
2. Measure effectiveness of current improvement strategies to determine critical causes of student underachievement.
3. Identify a limited number of achievement goals, key improvement strategies to achieve goals and fiscal resources. Verify that the ConApp allocations match SPSA Form C, "Programs Included in This Plan."
4. Attach timelines, personnel responsible, proposed expenditures, and funding sources to implement the plan.
5. Recommend the SPSA to the local governing board.
6. Receive local governing board approval and implement the plan.
7. Monitor and evaluate effectiveness of the implementation.

By following the Seven Steps for Developing the SPSA, and with information from the CDE “School Plan for

Student Achievement” presentation⁴, the following sections of the template can be completed. Collectively, these completed forms will make up the SPSA for a school:

- **Goals, Actions, and Services** — develops school goals, expected outcomes, related actions, and expenditures that address the findings from the analysis of the instructional program and student performance data. School Plan for Student Achievement Annual Evaluation

Pursuant to California *Education Code* Section 64001(g), the School Site Council (SSC) must evaluate at least annually the effectiveness of planned activities. In the cycle of continuous improvement of student performance, evaluation of the results of goals will provide data to inform and guide subsequent plans.

Annual evaluation by the SSC and local educational agency (LEA) is a critical part of the continuous cycle of improvement for a school. Furthermore, it is an integral component of the Compensatory Education (CE) Federal Program Monitoring (FPM) review process for School Plan for Student Achievements (SPSAs). During an FPM review, the SSC and LEA must be able to provide evidence of the evaluation process to determine if the needs of students are being met by the strategies described in the SPSA.

The SPSA annual evaluation may be a summary description of the school’s progress toward implementation of the strategies and actions in the SPSA. The school may include data voluntarily developed by districts to measure pupil outcomes (described in the Identified Need); and
 - b. Be based on academic achievement information about all students in the school, including all groups under §200.13(b)(7) and migratory children as defined in section 1309(2) of the ESEA, relative to the State's academic standards under §200.1 to—
 - i. Help the school understand the subjects and skills for which teaching and learning need to be improved; and
 - ii. Identify the specific academic needs of students and groups of students who are not yet achieving the State's academic standards; and
 - iii. Assess the needs of the school relative to each of the components of the schoolwide program under §200.28.
 - iv. Develop the comprehensive needs assessment with the participation of individuals who will carry out the schoolwide program plan.
 - v. Document how it conducted the needs assessment, the results it obtained, and the conclusions it drew from those results.
 - B. Identification of the process for evaluating and monitoring the implementation of the SPSA and progress towards accomplishing the goals set forth in the SPSA (described in the Expected Annual Measurable Outcomes and Annual Review and Update).

Requirements for the Plan

- II. The SPSA shall include the following:
 - A. Goals set to improve pupil outcomes, including addressing the needs of student groups as identified through the needs assessment.
 - B. Evidence-based strategies, actions, or services (described in Strategies and Activities)
 1. A description of the strategies that the school will be implementing to address school needs, including a description of how such strategies will--
 - a. provide opportunities for all children including each of the subgroups of students to meet the challenging state academic standards
 - b. use methods and instructional strategies that:
 - i. strengthen the academic program in the school,
 - ii. increase the amount and quality of learning time, and

- iii. provide an enriched and accelerated curriculum, which may include programs, activities, and courses necessary to provide a well-rounded education.
 - c. Address the needs of all children in the school, but particularly the needs of those at risk of not meeting the challenging State academic standards, so that all students demonstrate at least proficiency on the State's academic standards through activities which may include:
 - i. strategies to improve students' skills outside the academic subject areas;
 - ii. preparation for and awareness of opportunities for postsecondary education and the workforce;
 - iii. implementation of a schoolwide tiered model to prevent and address problem behavior;
 - iv. professional development and other activities for teachers, paraprofessionals, and other school personnel to improve instruction and use of data; and
 - v. strategies for assisting preschool children in the transition from early childhood education programs to local elementary school programs.
- C. Proposed expenditures, based on the projected resource allocation from the governing board or body of the local educational agency (may include funds allocated via the ConApp, federal funds for CSI, any other state or local funds allocated to the school), to address the findings of the needs assessment consistent with the state priorities, including identifying resource inequities, which may include a review of the LEAs budgeting, it's LCAP, and school-level budgeting, if applicable (described in Proposed Expenditures and Budget Summary).  - 1. Ensure that those students' difficulties are identified on a timely basis; and
 - 2. Provide sufficient information on which to base effective assistance to those students.

- G. For an elementary school, a description of how the school will assist preschool students in the successful transition from early childhood programs to the school.
- H. A description of how the school will use resources to carry out these components (described in the Proposed Expenditures for Strategies/Activities).
- I. A description of any other activities and objectives as established by the SSC (described in the Strategies/Activities).

What changes to goals, actions, services, and expenditures are being made in the SPSA as a result of the review of progress and assessment of the effectiveness of the actions and services?
- 5) What differences are there between budgeted expenditures and estimated actual annual expenditures? What were the reasons for any differences?

Guiding Questions: Stakeholder Engagement
