San Jacinto USD is proposing to receive 32 slots to increase hours of service.

Currently, San Jacinto USD operates 40% full-day classrooms and 60% part-day classrooms. Two full-day classrooms are at our San Jacinto site and two other full-day classrooms are at our Hyatt site. San Jacinto would like to operate above 50% of full-day classrooms by converting one of our part-day classrooms into two full-day classrooms. Having two more full-day classrooms will provide support to our working families and those who are attending school to continue their education.

4. Explain staffing increases for each applicable condition.

Staffing increase will include:

- One teacher (8 hours)
- One instructional aide (7 hours)
- One custodian (8 hours)
- One floater/rover aide (5 hours to release teachers and aides for breaks and lunch)

Note: The current part-day teacher and instructional aide will become the full-day teacher and instructional aide. We will hire another teacher and instructional aide for the other full-day classroom.

5. Identify the sites at which the services are proposed, why these sites were selected, the proposed number of classrooms, and the proposed number of children to be served for each applicable condition.

Our Hyatt Preschool site will be the propose site for additional full-day services. Currently at the Hyatt site, we have one part-day classroom that will be converted into two full-day classrooms. The number of children that will be served full-day services is 32 (16 children in each classroom).
